## **GLASS SCULPTURE AND GARDEN**

## August 27 - September 18, 2022 Munster, Lüneburg Heide

## **Participation rules**

- 1. The exhibition will take place in the city of 29633 Munster, Lüneburger Heide (Germany) in the public parks.
- 2. The organizer of the exhibition is the city of Munster.
- An art prize of 6.000 € will be offered for the glass artworks in the outdoor area. An independent jury will decide on this. The prize will be awarded at the opening of the exhibition. The prize money can be divided. At the finissage an audience prize of 500 € will be offered, which will be divided in case of a tie.
- Each artist must exhibit at least one glass artwork in the outdoor area. The maximum number is two glass artworks. For each outdoor glass artwork, one additional small glass sculpture may be exhibited indoors.
- 5. Only artworks for which a commitment has been made may be exhibited. The titles of the artworks may not be changed.
- 6. The artworks must be predominantly made of glass, (at least 50%). They must be of such a nature that they are suitable for display in public outdoor spaces.
- 7. The location of all artworks is determined by the artistic direction. There is no entitlement to a specific location.
- 8. The delivery / set-up of the artwork as well as the dismantling / return transport are the sole responsibility of the artist. The same applies to any customs procedures that may arise or any customs duties that may have to be paid. The City of Munster will not assume any costs or responsibilities in this regard.
- The Artwork must be set up between Thursday, August 25, 2022, beginning at 10:00 a.m. and Saturday, August 27, 2022, no later than, 09:00 a.m. Construction must be completed no later than 10:00 a.m. on August 27, 2022. Late delivery will result in exclusion.

Dismantling of the artwork may begin no earlier than 4:00 p.m. on Sunday, September 18, 2022 and must be completed no later than 4:00 p.m. on Monday, September 19, 2022.

- 10. The works of art are not insured by the City of Munster. The city assumes no liability for possible damage.
- 11. Each artist will be paid a travel allowance after personal participation at the end of GLASPLASTIK UND GARTEN 2022. Bank details are required for this purpose. The travel allowance is staggered:

-Inside Germany:	300,00€
-Inside Europe:	400,00€
-Outside Europe:	500,00€

- Application deadline is December, 1<sup>st</sup>, 2021 (date of postmark or e-mail receipt).
- 14. The application consists of the following documents:
  - Application form
  - Photos/drawings of the glass artworks to be exhibited. (Marking with name, first name and title required).
  - Curriculum vitae/resume (max. 500 characters) in German and/or English only.
  - Portrait photo of the artist (min. 300dpi, file: jpg, tiff).
  - 2-5 photos about already realized artworks
- 15. Any glass artist can apply. An independent jury will decide on admission by the end of January 2022. Corresponding acceptances or rejections will be made in writing by the end of February 2022.
- 16. Authentic photos of the approved artworks for publication and promotion (in the catalog, print media and on the web) are to be submitted by email or by post until May 1<sup>st</sup>, 2022. Photo files (jpg/tiff) must have sufficient print quality of at least 300 dpi. Failure to submit on time may result in disqualification. Sketches/drawings of the artwork will not be accepted for this purpose.
- 17. By signing the application form, the artist accepts these participation regulations and expressly agrees to the publication of the submitted photos, personal data (vita, surname, first name, street, house no., postal code, city, telephone, fax, e-mail and website) as well as the data and photos of the artworks.

This consent also applies to all publications / advertisements (print and digital) published in connection with the exhibition GLASPLASTIK UND GARTEN. This also includes the website: www.glasplastik-undgarten.de. The city is thus released from data protection.

- 18. If an artwork from the exhibition is sold, the purchase will be handled by the City of Munster. The works of art will remain in the exhibition until September 18, 2022. The City of Munster will receive a commission of 25% of the sale price. The remaining amount (75%) will be transferred to the artist at the end of the exhibition to the same bank account as for the travel allowance. In case of destruction or defect of the artwork during the exhibition, the sales contract becomes invalid. A reversal will take place.
- 19. The legal process is excluded.
